

## Terms and Conditions EANM Focus Meeting 5 Registration



### 1) Data Protection Clause

I acknowledge that EANM obeys the International Data Protection Guidelines; I agree that my given data may be used and processed by EANM for the management of membership data as well as other EANM purposes (e.g. distribution of newsletter and other EANM information, promotion of EANM Congress, educational/scientific activities, etc.) and may be forwarded to the publisher/distributor of EANM publications.

### 2) Payment of Registration

Payments with credit card will be confirmed automatically by the system. Payments with bank transfer will be confirmed as soon as the money arrived in the registration account.

If the full amount of your early registration fee has not been received on the below mentioned bank account by **October 31, 2022**, the advanced registration fee will automatically become effective. Therefore, we strongly recommend paying last-minute registrations via credit card only!

In case you have chosen bank transfer as mode of payment, please note that the registration fees need to be paid by **December 16, 2022**. In case the payment is not received by this deadline, the registration will be cancelled, and your reserved seat will be made available to other registrants.

### 3) Bank Transfer Charges

All bank charges for the transfer service must be paid by the participant. Open amounts must be settled before receiving a congress name badge.

### 4) Travel and Accommodation

The EANM is not in charge of taking care of your travel arrangements. All arrangements need to be done by the participant. Hotel recommendations can be found on the Focus Meeting website.

### 5) Name Badges

The badges for the congress will only be issued on-site between February 2 and February 4, 2023. The badges must be collected in person.

A confirmation will be issued upon successful completion of registration.

### 6) Cancellation of Registration

Substitutions will be accepted if the name and email address of the substitute are sent to the EANM Office ([focusmeeting@eanm.org](mailto:focusmeeting@eanm.org)) no later than **December 16, 2022**. Name and email address of substitutes need to be sent in the same email as the notification of cancellation.

In the event of cancellation before **December 16, 2022** a refund of your registration fee minus a charge for administrative proceedings of EUR 100,- will be made after the event. Any cancellation received after **December 16, 2022** will not be accepted (e.g. 100% cancellation fee). Delegates are strongly advised to secure appropriate travel and health insurance. Delegate registration fees do not provide any such insurance coverage. The EANM accepts no responsibility or liability against cancellations of bookings, loss or inconvenience or theft/damage to belongings in this regard.

## **7) Liability**

Should technical reasons beyond the control of the organisers make any changes necessary, EANM cannot be held responsible. Furthermore, EANM cannot be held responsible for any loss, injury or damages to any person or property whatever the cause may be. The liability of persons and enterprises providing means of transportation or other services, however, remains unaffected. The participant(s) take(s) part at his/her/their own risk. Only written arrangements are binding. Sole congress venue is Seville, Spain. With your registration you authorise the organiser to use all registration data given in the registration form for the computerised handling of the congress and further communication with all respective suppliers. Austrian law shall apply and place of jurisdiction is Vienna.

The EANM accepts no liability if an event is cancelled or postponed for reasons beyond its reasonable control resulting e.g.: from an act of God, governmental regulation, fire, war, terrorist activity or civil commotion, pandemic (COVID or similar) etc. If the EANM elects to re-schedule the conference, all registrations and additional items are automatically rolled over to the new dates of the conference. If the EANM elects to cancel the event, the liability is limited to a refund of registration costs, subject to fees and conditions. The EANM will not refund any travel costs associated with the cancellation of the event. Any accommodation pre-payment refunds are subject to the terms and conditions of the hotel.

## **8) Disclaimer**

In the event the event has to be cancelled by the organisers because of force majeure, only the registration fee will be partially refunded or forfeited, which is subject to the commitments of the congress organisers at that time, travel & accommodation has to be insured by the participant him-/herself.

## **9) Media**

By attending the event, each participant acknowledges and agrees to grant EANM the right at the congress to record, film, photograph or capture the likeness of such participant and its representatives in any media now available and in the future developed, and to use, copy, modify, distribute, broadcast or otherwise disseminate at any time and on a global basis such media, without any further approval from or payment to such participant or any of its representatives.

Attendees must be fully vaccinated against COVID-19 (meaning: a person has received all recommended COVID-19 vaccines, including any booster dose(s) when/where eligible.) and masks might be required.

The following EU valid vaccines are eligible: Pfizer-Biontech, Moderna, Astra-Zeneca, Jansen / Johnson & Johnson, Sinovac and Sinopharm.
